

MONEYSOFT END-USER LICENCE AGREEMENT for Money Manager software

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENCE AGREEMENT CAREFULLY BEFORE INSTALLING THE SOFTWARE:

Moneysoft Limited's End-User Licence Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Moneysoft Limited for Money Manager identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("Money Manager"). By installing, copying, or otherwise using Money Manager, you agree to be bound by the terms of this EULA. This Licence agreement represents the entire agreement concerning the program between you and Moneysoft Limited, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use Money Manager.

Money Manager is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. Money Manager is licensed, not sold.

1. GRANT OF LICENCE – INSTALLATION AND USE

Moneysoft Limited grants you the right to install and use a copy of Money Manager on your computer running a validly licensed copy of the operating system for which Money Manager was designed. Each valid User Licence is for use by one single user only. If you wish to operate Money Manager for multiple concurrent users then multiple licences are required. **Money Manager Business and Personal Edition** - facilitates the activation for an unlimited number of employers.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS

(a) Maintenance of Copyright Notices

You must not remove or alter any copyright notices on any and all copies of Money Manager.

(b) Distribution

You may not distribute registered copies of Money Manager to third parties. Evaluation versions available for download from Moneysoft Limited's websites may be freely distributed.

(c) Prohibition on Reverse Engineering, Decompilation, and Disassembly

You may not reverse engineer, decompile, or disassemble Money Manager, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(d) Rental

You may not rent, lease, or lend Money Manager.

(e) Support Services

Moneysoft Limited may provide you with support services related to Money Manager ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of Money Manager and subject to the terms and

conditions of this EULA.

(f) Compliance with Applicable Laws

You must comply with all applicable laws regarding use of Money Manager.

3. TERMINATION

Without prejudice to any other rights, Moneysoft Limited may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of Money Manager in your possession.

4. COPYRIGHT

All title, including but not limited to copyrights, in and to Money Manager and any copies thereof are owned by Moneysoft Limited or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of Money Manager is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by Moneysoft Limited.

5. NO WARRANTIES

Moneysoft Limited expressly disclaims any warranty for Money Manager. Money Manager is provided 'As Is' without any express or implied warranty of any kind, including but not limited to any warranties of merchantability, non-infringement, or fitness of a particular purpose. Moneysoft Limited does not warrant or assume responsibility for the accuracy or completeness of any information, text, graphics, links or other items contained within Money Manager. Moneysoft Limited makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb, or other such computer program.
